March was national Safety Dig Month

Efforts are being made by utility companies to promote safe habits by the public when you are planning to dig in areas where underground utilities are possible (gas lines, power lines, Communication lines, sewer lines, water lines).

At least 48 hours before you dig call the Ohio Utilities Public Protection Service (O.U.P.S.) at **1-800-362-2764 or 811** to locate any underground utility lines.

Besides being a possible hazzard to yours or someone else's safety, if you damage any utility line you could be responsible for the cost to have them repaired.

In March, Suburban Natural Gas Company began a 4 year infrastructure upgrade project running through Big Island Township. If your property is effected by their work you should have been notified directly by their company or you will be.

Road Clean Up To Begin

When the weather breaks, local 4H club members will again be going along the township roads cleaning up litter. We are very grateful to the members who are participating in the clean up for their outstanding effort and community involvement.

As you drive down the township roads this spring watch for these young people as they work to make our township a cleaner place to live.

Big Island Township and the county exchange roads

Due to the increase in traffic and demand for service and care that will accompany the construction of the new Elgin School Campus, the township and county have exchanged ownership of several roads this past year.

The county will now be responsible for the section of Keener Road from State Route 203 to LaRue - Prospect Road. This includes repair and maintenance and snow removal. The county also received the section of Espyville Road between LaRue - Prospect Road and LaRue - Green Camp Road.

In exchange for these two roads the township received all of Seiter Road and the section of Espyville Road north of LaRue - Prospect Road.

Before you dig call 1-800-362-2764 or 811

Information you will need to have available and ready when you call the Ohio Utilities Protection Service (O.U.P.S.):

- Your name
- Your address
- Your phone number
- Location where you want to dig
- Date you want to dig
- Type of work you want to do

Steps to ensure a safe dig:

Wait until the area is marked by O.U.P.S.

Be sure to maintain proper clearance between the marked utility and your digging equipment

Markings are only approximate location of buried lines. Carefully hand dig 18" on each side of the markings until you find the line. If you have trouble locating it call O.U.P.S. or the utility company for assistance with locating the line prior to further digging

If you hit a line

- Stop digging
- Do not attempt to make any temporary repairs
- Call the appropriate utility company to inspect the line and make all necessary repairs
- If any hazards exist call 911 and leave the area

Gas Line Precautions

Recognizing a gas leak

- 1. Gas odor
- 2. A blowing or hissing sound
- 3. Water bubbling or being blown into the air at a pond, creek or river
- 4. Fire coming from the ground or burning above the ground
- 5. Brown patches of vegetation on or near a gas line
- 6. Dry spot in moist earth

If you suspect a leak

- Leave the area at once. Warn others to stay away
- 2. Do not us potential ignition sources, such as motor vehicles, telephones, electric switches
- 3. Call 911 and the gas company
- 4. Never try to extinguish a gas fire or operate any pipeline valves

Underground Utility Marker Identification Color Code:

Red - Electric Power Lines, Cables, Conduit and Lighting Cables

Yellow - Gas, Oil, Petroleum or Gaseous Materials

Orange - Communication, Alarm or Signal Lines, Cables or Conduit

Blue - Potable Water

Purple - Reclaimed Water, Irrigation and Slurry Lines

Green - Sewers and Drain Lines

Pink - Temporary Survey Markings

White - Proposed Excavating


Township Zoning Regulation Reminder

There shall be no more than one (1) wrecked, unlicensed or otherwise inoperable automobile allowed per one (1) dwelling unit. Such automobile may be stored only for a period not to exceed 60 days per year and such parking or storage space shall be enclosed by structure, fence or otherwise protected so that the automobile cannot be entered upon or seen from an adjacent lot or street.

The definition of "junk motor vehicles" means any motor vehicle meeting all of the following requirements:

- A. Three (3) years or older;
- B. Extensively damaged, such damage including but not limited to any of the following: missing wheels, tires, motor, or transmission;
- C. Apparently inoperable;
- D. Having a fair market value of Four Hundred Dollars (\$400) or less.
